Unfortunately, the poor economy hits those on fixed incomes especially hard. Health, welfare, and aging programs are likely to face substantial cuts this year. We anticipate suspension of the Supplemental Security Income cost of living increase and deep cuts to the Medi-Cal program, including the termination of dental services.

Ed Burnett is living on Social Security and is partially disabled. Sonny, Ed's adult son, had taken a wrong turn, and since his release from prison two years before had become an addict. He became increasingly abusive to Ed and one night Sonny kicked Ed's door down and clubbed and punched him to the ground while screaming for money. Sonny was arrested that night, but Ed knew he'd be back.

LAE attorneys successfully petitioned the court for a three-year restraining order to keep Sonny away from Ed. Ed later discovered Sonny had been jailed for possession of firearms. Since 1977, LAE has helped thousands of older people confronted with crises including elder abuse, housing and health care issues, and denial of government benefits. LAE is the only legal services provider in San Francisco that deals exclusively with seniors and their specific needs, including assistance in their own languages.

In 1984, Bernice, who was in her 70s, executed a quitclaim deed to her son John for the duplex she owned and lived in, giving him her share of the property in the belief that John would better to be able to care for her needs. But in 1991, based upon an erroneous diagnosis of Alzheimer's in Bernice, John moved Bernice out of her home against her will and into a rundown board-and-care facility. LAE attorneys intervened and were able to get Bernice out of the facility and back into her home.

By 2001, Bernice was in her 80s. John went to court and filed an action to partition Bernice's interest in the property. Once again L.A.E. intervened, and while John's partition action was granted, LAE attorneys helped Bernice obtain \$400,000, enough to care for her for the rest of her life. Whether it's getting a restraining order to stop elder abuse, fighting an unlawful eviction, or joining a nationwide class action lawsuit to stop unfair health benefit cut-offs, LAE has been there for our elder parents, relatives, and friends in their time of legal need.
